 The letter advised that recent training and exercise provided to the Secondary school staff by Harrison Tew had been very successful. Harrison Tew were very confident that SLT had demonstrated the appropriate knowledge and confidence to deal with a wide range of emergencies and incidents which intended to keep their students, staff and visitors to the school safe.

Principal's Primary School Report

- Daniel spoke to his report dated 23 March 2023 which the board received a copy of prior to the meeting.
- Daniel spoke to the survey results regarding student voice around PAT testing and provided this as an attachment to his report
- Daniel spoke to the board assurance statement. Daniel asked the board to review

- Daniel said he felt confident with his recent discussions with MOE around the new builds. Plans to start are currently on hold until funding is approved for the construction phase including consents. Daniel said he is happy with how things are progressing. Discussions around playground funding should be shown in the May budget as well as options for re-housing the temporary spaces with off-site as an option (which Daniel preferred not to go with that option).

Principal's Secondary School Report

- Maurie spoke to the Secondary Principal's school report dated 23 March 2023
- Maurie said he updated the target data for the charter and presented the amended version to the board.
- Maurie spoke to the NCEA summary and highlighted current vs previous years data.
- Maurie reported that 57% of all leavers left with NCEA L3, 26% at Excellence, 20% 86% graduated with Level 2 or 2 compared to 84% in 2021.
- Graeme asked how is the school communicating the scholarships to the community,
 Maurie said we had done those communications already through our whanau comms

- Maurie provided the board with a complete anonymised sheet of all leavers who
 graduated with less than NCEA L2. As well as an updated NCEA Analysis document
 showing the shifts which improve the results further.
- The board were shown a document outlining the Strategic Planning, Self Review and Reporting to the community as well as draft policies for review. The board were able to read over this prior to the meeting. A link was included to sign the procedure assurances for term 1.
- Maurie reported that the professional growth cycle (replacing appraisal) process for 2023 will be underway soon with SLT scheduling 2 on 1 hui with staff this term.
- A proposal to raise homestay fees for international students was included in this report.
- Maurie was pleased to advise to the board that Ros Britton had been appointed as the Deputy Principal replacing Lea Vellenoweth
