### **Secondary School Principal's Report**

- Maurie spoke to his Principal's school report dated May 2020 which the board were given a copy of.
- Maurie said Planning for moving into and operating within Alert Level 3 has been carried out and implemented. No students attended school during Alert Level 3.
- Maurie said we will need to revisit our 2020 Action Plan and amend our goals, actions and targets as a result of COVID19. Maurie attached a document for the board to review which captures our thinking around the action plan with suggested actions to be amended and suggested changes to be made.
- Mauries response to picking up students' anxiety around NCEA. Maurie said staff have been working in teams to see how they can cross credit in multiple learning areas.
- Maurie said there are two policies there for the board to view.
- The board were able to view the plan put in place at Level 2 - COVID19.

### **Finance & Property Report**

- Graeme recommended a mid year meeting to reassess where we are at with the current budget and what effect COVID19 has had on the budget.
- Graeme said where there is a slightly unusual rise in the BOT budget, this is due to the related costs of COVID19 expenses being assigned to the BOT line in the interim.
- Graeme said we estimated that school donations may be down under the current circumstances. We are fortunate though that it does not impact significantly on what we are doing because of the surplus situation that we are faced with.
- Maurie said schools who purchased chrome books whilst in lock down have now been reimbursed. There is support by the government for certain spends during COVID19.

### **Student BOT Rep**

Maurie said it was the Kaiarahi that made him aware of how students were feeling around NCEA. Their ability to communicate through their facebook page has been really good.
- Meredith said she would like to acknowledge Selena and the kaiarahi for being great role models for the primary school leaders group. Graeme said it's nice to see a good chunk of the primary school having te reo included in their student support.

### **General Business**

- Meredith asked the board about their vote for NZSTA President. Lorraine Kerr - Current President. Meredith said she doesn't really know much about any of the others. Meredith said as a board do we want to continue to support Lorraine or do we vote for someone else. Meredith said it closes on 28 May. Meredith suggested we read through the profiles which Maliina will organise to get these sent.
- For the other voting paper we can vote for up to 6 people. Graeme will submit our board's vote as Meredith is standing for election.
- Meredith said just a follow up with the NEPAL trip, the insurance company is still processing our claim. Maurie said we are in a fairly good position because ANTIPODEANS cancelled the trip rather than the school. Each individual student has paid \$8,500 and the trip was supposed to take place in the school holidays (15-19 students have been affected).
